NOTIFICATION

No. 2038-WT/3M-28/2021

Dated : the 2nd August, 2021.

Whereas Ministry of Road Transport and Highways, Government of India, issued Notification Nos, S.O. 3467(E) dated 16-07-2018 and S.O. 3881(E) dated 06-08-2018 in exercise of the power conferred in sub-section (1) of section 58 of Motor Vehicles Act 1988, notifying maximum safe axle weight of each axle type in respect of the transport vehicles (other than motor cabs), on the basis of their size, nature and number of tyres ;

And whereas the Director (MVL), MoRTH, GoI, under his letter no. RT11028/11/2017-MVL Dated 18-07-2018 recommended to increase the permissible axle weight of transport vehicles and subsequently in para 2 of his letter no. RT11028/11/2017-MVL Dated 07-08-2018, advised that Transport departments of the states may take necessary action to incorporate the revised GVW in the registration particulars of the transport vehicles ;

And whereas Government Of West Bengal in the Transport Department after careful examination of all aspects and being satisfied deems it expedient to implement the revised axle weight in terms of the Notifications as stated above ;

Therefore, it is ordered that the maximum safe axle weight of each axle type in respect of the transport vehicles (other than motor cabs) as prescribed in the Govt. of India notification numbers S.O. 3467(E) dated 16-07-2018 and S.O. 3881(E) dated 06-08-2018 shall be effective in the entire state of West Bengal and it will be applicable to all the vehicles already registered in this state. Further, the registration particulars of the transport vehicles will be revised to incorporate the revised GVW, on application by the vehicle owner, subject to fulfillment of the terms and conditions as laid down in the notifications above of MoRTH and on payment of necessary fees and revised/ enhanced taxes as applicable for West Bengal.

This order will come into effect immediately.
